## MEMBERSHIP INFORMATION

The following information is provided to members at 1<sup>st</sup> May 2026

### **Payment of Membership Fees:**

The Board wish to clarify that all members are bound by the Club's Byelaws and Regulations.

Payments are requested to be made promptly and in full by one of the following payment options:

- **Option 1 – New HowDidIDo or ClubV1 app**, by credit or debit card [no AMEX]. This is the quickest and preferred method of payment as your membership record will be automatically updated.
- **Option 2 - Bank Transfer** - To the club's bank account as noted on the renewal notice, or
- **Option 3 – With the office if you are unable to pay via one of the apps** – payment by credit or debit card [no AMEX]. **Cash Payments** – for security we wish to keep this to a minimum and ask that you choose to pay by one of the alternative options.
- **Option 4 – 3<sup>rd</sup> Party Finance** – HowDoiPay-Later is available via the **New HowDidiDo** or **ClubV1 app**

### **Categories of Membership:**

#### **7 Day Golf: [Full / Intermediate / Youth]**

Offers access to the course each day, subject to diary / tee bookings. WHS handicap index, competition entry, social / club events.

#### **5 Day Golf: [Full / Intermediate]**

Offers unrestricted use each weekday, subject to diary / tee bookings. WHS handicap index, competition entry, social / club events.

**Temporary Categories [Waiting List]** - Categories will be determined by the Board should a waiting list be in place.

## Overseas and Country Membership: [Associate Membership Scheme - Flexible]

For members living **over 40 miles** from the club. The membership will continue to follow the **associate category** model as detailed below but with the following criteria:

- **UK Residents** - Members must be domiciled at least 40 miles away from SHGC and provide a photographic ID and confirmation of address [driving licence].
- **Overseas Residents** – Members will be required to provide confirmation that they are resident and/or working abroad for a minimum period of 6 months of the subscription year.
- WHS handicap index, social / club events, competition entry is subject to the following restrictions
- Members may enter all eligible club competitions except are unable to win an honours board competition.

We hope that you will continue to take advantage of the club and its facilities when you are in the area to do so.

Your Associate Membership Account will be issued with £606.00 of credit to be used by 30<sup>th</sup> April 2027; this will be held in a separate purse.

- Prior to playing the course (either casually, competitively or representing the club in friendly matches) associate members will be required to present their membership card to the professional shop or bar where the appropriate fee will be deducted – weekday at £36.70; weekends and Bank Holidays at £50.50. Guest green fees may not be charged to the account.
- If you need to 'top up' your account this may be done at any time during the membership year, the minimum amount is £100.00. A top up balance may be carried forward upon renewal at 1<sup>st</sup> May 2027.
- Associate Members may enter all eligible club competitions **except** they are unable to win honours board competitions and to represent the club in official matches but may play in club friendly matches.
- If it is found that an associate member has played the course without paying the appropriate fee prior to their round, membership of the club will be suspended with immediate effect and subject to the club's disciplinary procedures.

## Other Items:

**Joining Fee** – Applicable to all categories of membership except for youth and house. A fee of £750 payable upon joining which is split across 3 payments of £250; this may be reduced to a one-off payment of £500 upon joining.

**Bar Levy** – A £50 levy on each member [aged 18 and over] to be used on food and beverage. As per the Byelaws and Regulations ‘unused bar levy, except for top-ups, will be forfeit at the end of the subscription year’.

**Club Share** - Members of the club who are 18 years and over at the time of joining are required to hold a £5 share [plus £5 admin charge], unless stated. This is a one-off £10 charge and the share is refundable at its £5 face value should you no longer be a member of the club.

**Member Benefits** – this year the following initiatives will be included with your membership

- Golfing membership includes social membership for a spouse or partner residing at the same address, please see fee structure below.
- Member Card Discount on bar sales with additional Food & Beverage promotions during the year, and beneficial rates on group bookings for a clubhouse event.
- Reciprocal green fee arrangement with Chestfield GC and Kings Hill GC, conditions apply.

## Kent Golf and England Golf Affiliation Fees:

**Golf Affiliation Fees** – Fees are collected on behalf of, and upon receipt passed on to, the County and National Golfing Unions. As part of your affiliation you have access to the following:

- **County Card** – Please download the ‘igCounty’ App from the google store. This App is available for both male and female golfers and you will need your CDH number to register. You may use the County Card scheme at participating clubs.
- **Insurance [Golfing Members]** - Golf is a dangerous sport, and you should be insured to cover your liability for 3<sup>rd</sup> party property damage, personal injury, and loss of equipment. England Golf currently provide Personal Liability Insurance (only) to members with an indemnity of up to £10 million. Please see the England Golf website for further details <https://www.englandgolf.org/benefits> Should you need to make a claim you will require your lifetime CDH ID number.

The club has covered all golfers, members and visitors, when playing at Shooters Hill for personal liability, 3rd party property damage, personal accident, and in addition members are covered for hospitalisation, dental and optical injury, loss of subscriptions, loss of tournament fees and hole in one. The Policy Schedule and Wording will be available on the app in the documents section.

Cover away from the club - There are various insurers who can provide annual insurance to cover you when playing at other clubs, and some of you may already have cover. The club have received an option for insurance cover and information will be circulated in due course.
