

JOINING INFORMATION

Payment of Membership Fees:

The Board wish to clarify that all members are bound by the Club's Bye-Laws and Regulations which states that all fees are payable in advance of the commencement of membership.

Payment of your fees can be via the following options:

- Bank Transfer To the club's bank account, or
- **Debit/Credit Card** With the office either in person or over the phone, or
- **Personal Finance** A facility is available for members to pay by instalments. Please click on the link on the club website, under the 'membership' tab, to initiate the process.

Subscriptions – Please refer to page 3 for the current fees. These are pro-rata at the 1st of each month.

Bar Levy – A £50.00 levy is applied to all members [aged 18 and over] to be used on food and beverage. As per the Bye-Laws and Regulations 'unused bar levy, except for top-ups, will be forfeit at the end of the subscription year'.

Joining Fee - All applications [aged 18 and over] received after 1st January 2022 will be subject to a fee of £750.00 payable in 3 instalments or £500.00 in full at the time of joining.

Insurance:

Golfers Members - England Golf currently provide Personal Liability Insurance (only) to members with an indemnity of up to £10 million. Please see the England Golf website for further details https://www.englandgolf.org/

You may wish to consider insurance to cover your golf equipment, and reimbursement of your annual subscription in case you are unable to play due to injury at/away from the club and/or medical reasons. As per the Club's Bye-Laws and Regulations membership fees are non-refundable.

There are various insurers who can provide annual insurance for you which are advertised in the golfing press or online.

Categories of Membership:

- **7 Day Category [unrestricted]** Allows for play at any permitted time subject to tee closures as noted on the club's diary or notified by the club.
- **7 Day Temporary Categories** are only available to new applicants to the club where the [unrestricted] 7 Day Category of membership has a waiting list and not currently available.

- Restricted 7 Day [Temporary Category] Allows for play at any permitted time subject to tee closures as noted on the club's diary or notified by the club, along with the following conditions.
- Access to the course is not restricted on a weekday but play is restricted at the weekends to after 2pm [BST] and after 12pm [GMT].
- As soon as a 7 Day [unrestricted] place becomes available and notified to the member the balance of the subscription is due in full, if applicable. The place may not be declined or deferred.
- This Restricted 7 Day category is a temporary category and may only continue through a renewal by virtue of no places being available on the [unrestricted] 7 Day Category.

Should this category become full an additional Restricted Category will be available to the waiting list as follows:

- Summer Restricted 7 Day [Temporary Category] Allows for play at any permitted time subject to tee closures as noted on the club's diary or notified by the club, along with the following conditions.
- Access to the course is not restricted on a weekday but play is restricted at the
 weekends to after 4pm during the months of April to September with <u>no</u> weekend
 play permitted during the months of October to March.
- As soon as a 7 Day Restricted or Unrestricted place becomes available and notified to the member the balance of the subscription is due in full, if applicable. The place may not be declined or deferred.
- This Summer Restricted 7 Day category is a temporary category and may only continue through a renewal by virtue of no places being available on either the Restricted or Unrestricted 7 Day Categories.
- **5 Day [Weekday]** Allows for play at any permitted time Monday to Friday subject to tee closures as noted on the club's diary or notified by the club. Members may use the club socially at the weekends.
- Overseas & Country Please contact the office for further information.
- **House** Allows for use of the clubhouse facilities.

Golf Affiliation Fees – These fees are collected on behalf of, and paid over to, Kent Golf and England Golf.

County Card – As a Golf Member the 'igCounty' App can be downloaded from the google store. This App is available for both men and ladies and you will need your CDH number to register.
